## INSTRUCTIONS FOR COMPLETING THE APPLICATION FORM

- 2. Applications must be made only on the official form as prescribed by the FGN Roads Sukuk Company 1 PLC.
- 3. Applications must be for a minimum of \(\frac{\pmathbf{4}}{10,000.00}\) and thereafter, in multiples of \(\frac{\pmathbf{4}}{1,000.00}\). The value of the Sukuk applied for should be entered in the appropriate box.
